Policy & Procedure for college / university curriculum approval

Policy: Effective January 1, 2004, individuals seeking AAPS Counselor Credentialing shall have completed a minimum of 27 academic hours at an AAPS approved educational institution. (See Curriculum Components)

Purpose: To insure that AAPS credentialed counselors are receiving alcohol and drug specific education that incorporates the competency standards as identified in the Technical Assistance Publication (TAP 21) as published by the Substance Abuse Mental Health Services Administration.

Procedure:

- I. College or University contacts KAAP regarding interest in becoming an AAPS approved college or university.
- II. College or University submits application documents for KAAP Committee Review in the following format.

Application Documents

- a. Cover Letter with Introduction and statement of purpose.
- b. Completed Matrix document which lists courses offered and their direct relationship to the TAP 21 competencies and 27 credit hour format approved by AAPS
- c. Syllabi of each course (specific objectives relating to TAP 21).
- d. Qualifications of Faculty to Teach and Supervise the approved courses.
- e. College or University Commitment to the proposed program.

Procedure for Curriculum approval continued:

- III. College or University makes oral presentation to committee.
- IV. Committee reviews for curriculum adherence to TAP 21 competency standards for addiction counselors.
- V. College or University makes any revisions recommended by the committee.
- VI. Committee reviews submitted changes.
- VII. Process repeats until curriculum is recommended by committee.
- VIII. Committee issues letter of recommendation to College or University for curriculum approval.
- IX. College or University submits curriculum materials and letter of recommendation from the committee to AAPS.
- X. Upon final approval from AAPS, catalog is updated by AAPS, posted on the KAES list serve, and on AAPS web-site at <http://www.srskansas.org/hcp/AAPSHome.htm>
- XI. A copy of the curriculum and the approval letter shall be retained at AAPS. AAPS forwards all original materials to KAAP for archival storage.
- XII. Updates to approved Curriculums shall be submitted to KAAP/KAES for review then to AAPS for final approval. AAPS will update the catalog with approved revisions, distribute on KAES list-serve and post on AAPS web-site.
